## 3. Introduction

This short-term policy plan describes the goals of the 40<sup>th</sup> board of CHEOPS in the academic year 2025-2026. In this plan, an elaborate description of the yearly goals of the study association is given, supported by the ideas and means to realize these goals. The policy plan is a supporting document that provides the board and the members of CHEOPS with a clear insight in what the goals are for this year.

In the academic year 2016-2017 a long-term policy plan has been created by the 31st board, with the help of the members of CHEOPS. The CHEOPS Vision and Strategy Document describes the goals for the association stretching over multiple years. This document provides the basis for the policy plan for every board and is therefore included in this document. Every board has a different vision for their year and will work on their yearly goals in their own way. In order to get more insight, it is advised to read the document before laying eyes on the policy plan of the 40th board.

Our vision, Beyond Blueprints, is defined in the fourth chapter. In order to realize this vision, the following goals have been set up: "Internal Improvements" and the points of attention; mainly focusing on VAT reliability and reforming the policy plans. These are elaborated in the fifth chapter. This document will also include an introduction of the board and a division of tasks and committees.

## 4. Vision | Beyond Blueprints

Since its foundation, CHEOPS has undergone many changes, some bigger than others, yet there always was continuous improvement. At times, changes have already been initiated but still require proper implementation to reach their full potential.

With the vision 'Beyond Blueprints', the 40<sup>th</sup> board aims to strengthen the foundation of the association and further build upon what CHEOPS has already achieved. This vision reflects the idea of not only maintaining what has been achieved, but also daring to take the next steps toward long-term progress. Two main policy points define this approach. The first, 'Internal Improvements', focuses on increasing member involvement in activities and committees. The second goal consists of two parts. On the one hand, 'Finetuning Finances', which concerns the correct and most efficient implementation of VAT liability. On the other hand, 'Reforming Policy Plan', which explores how the process of drafting the policy plan can be optimized.

By pursuing these goals, the 40<sup>th</sup> board will go beyond the existing blueprints of the association. In doing so, it aims not only to preserve what has been built, but also to lay the groundwork for an even stronger foundation that will benefit CHEOPS.

## 5. Goals

## 5.1 Internal Improvements

One of the main goals of our board is to strengthen the involvement of both active and non-active members within CHEOPS. In recent years, the number of involved students (at activities) has decreased, which has made it more difficult to fill committees and to keep the association running smoothly. We believe that an enthusiastic and well-functioning group of members is the foundation of CHEOPS.

To achieve this, we will first focus on understanding why fewer students become active members. Research into current membership numbers, student interests, and reasons for non-involvement will give us a better picture of the situation. Based on these insights, we will experiment with different approaches throughout the year, and we will evaluate the results so they can be improved in the future.

The lustrum year provides unique opportunities to involve new members. Largescale and special activities will make CHEOPS more visible, which may inspire students to discover what the association has to offer. This visibility can also spark interest in joining a committee or helping to organize events themselves.

A specific focus will be placed on first-year students. During the introduction week, our approach was be less about giving standard promotional talks, and more about showing genuine interest in students and introducing them gradually to CHEOPS. We also aim to improve how we communicate what committees are and what they do, since many first-year students are not aware of this. Promotional moments such as promotion week, the book sale, and sign-up opportunities will be used to give a clearer image of the association. These efforts will be evaluated after each activity/event to adjust and improve the strategy. During the introduction week, the promotion of the BID proved to be insufficient. Due to a lack of registrations, the BID was cancelled for the moment and will hopefully be replaced with a similar weekend or evening later in the year.

To lower the threshold for students to visit CHEOPS, we will also organize informal initiatives such as free lunches. These small-scale and accessible events will provide opportunities for students who may not yet be familiar with the association to get to know it better. We will evaluate whether these lunches contribute to involvement and adjust them accordingly.

Committees will receive special attention, as some were not fully staffed in the past year. Furthermore, we will look at how other study associations attract and engage members, in order to adapt successful practices to our own situation.

By combining research, experimentation, and continuous evaluation, our board aims to make CHEOPS a more attractive and inclusive association for all Built Environment students.

### 5.2 Points of Attention

The 40<sup>th</sup> board of CHEOPS aims to address two developments within the association. These attention points are divided into two main elements. Firstly, completing what the 39<sup>th</sup> board has already started, which is becoming VAT liable. This attention point is centered around preventing and solving the upcoming challenges that will occur with being VAT liable, ensuring a smooth approach to be VAT liable for the upcoming years ahead. Furthermore, this attention point introduces a shift for the function of the Treasurer and the Audit committee. Secondly, the reformation of the policy plan will be investigated, aiming to create a more effective structure for future candidate boards. By involving former CHEOPS boards, members, and other (study) associations, the goal is to develop a framework that supports both feasibility and long-term improvement of policy making within CHEOPS.

#### Finetuning Finances

As of August 1st, 2025, CHEOPS has become VAT liable, introducing new responsibilities and challenges that the 40<sup>th</sup> board aims to prevent and solve. To address this, the board will review how expenses above €100 are declared, as these must be submitted with an invoice. In addition, the procedures for checking VAT during the Audits will be clarified, since these requirements are not yet fully defined.

The current intermediate financial overview will also be evaluated and improved to provide members with clearer insights while fully incorporating VAT-related aspects. As this is the first time CHEOPS faces VAT liability, it is essential to determine which methods work best, to document them properly, and to apply them consistently across committees, budgets, declarations, and invoices. In addition, the first tax assessment will take place in October, which means that the exact procedure must be investigated.

Through these steps, the 40<sup>th</sup> board aims to guarantee a smooth transition into VAT liability while safeguarding financial clarity and stability.

### Reforming the Policy Plans

Each year, the candidate board of CHEOPS identifies topics they wish to improve within the association. They then dedicate part of their board year to working on these chosen goals, with the intention that CHEOPS ultimately benefits from these policy plans. In recent years, however, it has become apparent that the process often leads the candidates to search for problems rather than to experience them directly. One of the reasons for this is that candidate board members have only a limited perspective on the association and its potential for growth. As a result, the policy plan does not always capture the full range of possibilities available. For this reason, we believe that the way policy plans are developed within CHEOPS requires change and reformation.

In order to find a better alternative for developing policy plans, research is required. First, the experiences of former board members provide valuable insights. By reflecting on their process of developing policy plans, we can identify what aspects worked well, what challenges they faced, and where improvements are needed in the process of drafting these plans.

Second, it is important to recognize that the way CHEOPS currently develops its policy plans is not the only approach. Many associations use different methods to improve themselves. To learn from these practices, we will have meetings with both current and former board members of other associations to understand how they have experienced the identification of their policy plans. While CHEOPS shares the most similarities with other study associations, we also aim to engage with different types of associations to gain broader perspectives.

Our goal is to provide a concrete solution for the 41st board of CHEOPS. Since the formation of the policy plan begins during their candidate period, which takes place in the fourth quartile of this academic year, we aim to have this action point completed by then. In this way, the 41st board will have a solid blueprint to guide them as they begin developing their own policy.

## 8. Changes Compared to Last Year

## 8.1 Committee Approach

In the upcoming year, some changes regarding the committees will be made. This year there will be a large trip committee added to the list of committees. Furthermore, the first year committees might be introduced later.

#### Large trip committee

Every two years a large trip is organized by CHEOPS. The large trip organized by the 38<sup>th</sup> board was a success. Therefore, the decision was made to do a large trip during this lustrum year as well, meaning that in the upcoming year, three trips are made. The lustrum weekend trip, the small trip and the large trip.

#### First year committees

Due to a lack of interest by first year students during the introweek, the Built Environment Introduction Days (BID) have been cancelled. In the past years, the first year committees were promoted during the BID, resulting in all four first year committees filled with students. This year, the possibility arises that these committees will not be filled at the start of the year. In promotion week one, the committees will be promoted with the hopes that students are interested in joining. The goal is to get some members in each committee, even if it is not enough. In case that committees are unable to be filled with enough people after promo week, the board takes on necessary tasks of the committees. Also, in the first quartile, as a replacement for the BID, a first year weekend is planned to be organized by the 39th board. In this weekend the first year committees will be promoted again to get enough members. The first faculty party will be organized by the Central Lustrum Committee, so therefore the party committee can start in quartile two. For the P-council, there is the option to promote it during lectures of first year courses. By starting the committees later, students have had time to get to know CHEOPS and might be more excited to join one of the committees.







## Goal 1: Internal Improvement
